## 9. AGM REMITS

There were two constitutional remits that were circulated to members in the 2016 Annual Report. Gillian Somers gave an overview of the remits as proposed in the Annual Report:

#### Remit 1:

# Delete the phrase

18.1 The books of the Association shall be audited annually and reported upon.

# Replace with

The books of the Association shall be reviewed annually and reported on.

# Delete the phrase

18.2 The Auditor will be a Chartered Accountant or a firm of Chartered Accountants appointed by the Annual General Meeting.

## Replace with

18.2 The Reviewer will be a Chartered Accountant or a firm of Chartered Accountants appointed by the Annual General Meeting.

#### Delete the phrase

18.3 In the event of any circumstance preventing the appointed Auditor, from auditing the books or if no Auditor is appointed by the Annual General Meeting, the Council will appoint one.

## Replace with

18.3 In the event of any circumstance preventing the appointed Reviewer, from auditing the books or if no Reviewer is appointed by the Annual General Meeting, the Council will appoint one.

Gillian Somers opened the floor for guestions on Remit 1:

Question asked by member of audience: How much money would be saved from moving to a review process from audit of accounts? Gillian Somers responded: "A couple of thousand dollars."

Question asked by Roberta Coutts: Is there a process to ensure there's no conflict of interest when choosing the Reviewer for the Accounts? Gillian Somers answered: Yes

#### Remit 2:

Gillian gave an overview of the proposal to reinsert an Honorary membership into the constitution.

#### Insert

5.2.4 Honorary Member: An Honorary Member is a person the Council considers to have provided outstanding service to the Association by way of time, effort, skills and knowledge, This person has had a minimum of eight years as a member or at a member kura (school). The nomination shall be considered at the Annual General Meeting at which a vote for the nomination of more than 75% of members entitled to vote will confer the status of "Honorary Member". An Honorary Member will have all the rights of members of the Association for his or

her life, shall not be required to pay any MANZ membership or annual conference registration fee and shall only have the membership terminated by resignation as described by point 6.

#### Insert

8.1.6 MANZ Honorary Members shall not be entitled to a vote.

Gillian opened the floor for questions/comments. Roberta Coutts stated that it was not clear on what the process is in nominating Honorary members. Cathy Wilson spoke and explained that a process would be written and circulated to members, however, it would not be necessary if this remit was not passed.
